

STACY BARBER POWER SKATING, LLC
WAIVER/RELEASE OF LIABILITY, ASSUMPTION OF
RISK, AND INDEMNITY AGREEMENT (Form for Minor)

In consideration of my minor child identified below (the “Minor”) being allowed to participate in Stacy Barber Power Skating, LLC. (the “Activity”), I, on behalf of the Minor, hereby make the following contractual representations pursuant to this waiver/release of liability, assumption of risk, and indemnity agreement (the “Agreement”):

1. I am of legal age and authorized to enter into this Agreement on behalf of the Minor.
2. I have read this Agreement carefully, understand its terms and conditions, and acknowledge that I will be giving up substantial legal rights by signing it.
3. The Minor is in good health and proper physical condition to participate in the Activity, and I am responsible for the Minor’s safety and well-being at all times and under all circumstances during the Activity.
4. I understand that the Minor is required to be familiar with and to abide by any rules and regulations established for the benefit and safety of all participants in the Activity. I accept sole responsibility for the conduct and actions of the Minor while he or she is participating in the Activity, and the condition and adequacy of the Minor’s equipment. I understand that the Activity organizers have the right to disqualify anyone or deny participation in the Activity for any reason they deem just and proper at their sole discretion.
5. I understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis, and death. I understand that these risks may be caused by my own actions or inactions as well as those of the Minor or others, including the negligent acts or omissions of the Released Parties defined below. On behalf of the Minor, I hereby **EXPRESSLY ASSUME** all such risks and responsibility for any damages, liabilities, losses, or expenses (including court costs and reasonable attorney fees) which I may incur as a result of the Minor’s participation in the Activity.
6. On behalf of the Minor, I hereby release the following parties: Stacy Barber, Don Barber, Riley Barber, Cullen Barber, Joseph Buckland, Lexi Zydeck, Mikhaila Neines, Cole Phillips, Maria Phillips, Marissa Phillips, Logan Bye, Thomas Ovelson, Alec Hamady, Grant Hindman and any other instructor, whether as an employee or volunteer, of Stacy Barber Power Skating, LLC (individually and collectively, the “Released Parties”), from any and all liability for damage and personal injury to me or my property (including court costs and reasonable attorney fees), which may arise out of, result from, or relate in any way to the Minor’s participation in the Activity, including any liability related to the negligent act or omissions of the Released Parties.
7. On behalf of the Minor, I agree to hold harmless and indemnify the Released Parties for any and all loss or damage the Minor may cause to person or property while engaged in the Activity. This includes, but is not limited to, any and all claims for personal injury, death, and/or property damage that may in any way arise out the Activity.
8. I have signed this Agreement without any inducement, assurance, or guarantee, and intend for my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions, and provisions of this Agreement.

This Agreement represents the complete understanding between the parties regarding these issues, and no oral representations, statements, or inducements have been made apart from this Agreement. If any provision of this Agreement is held to be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions.
